

## 2026 Ensemble Virtual Cruise Expo: Contest Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE DOES NOT INCREASE CHANCES OF WINNING. Further eligibility restrictions are contained in the Official Rules below. Void where prohibited by law, outside the United States and Canada, in the states of New York and Florida, and in the Province of Quebec. Subject to all federal, state, provincial, territorial, and local laws, regulations, and ordinances.**

These rules and regulations (the “**Official Rules**”) shall govern the 2026 Ensemble Virtual Cruise Expo: Contest (the “**Contest**”) for the Prize (as defined below). All entries in the Contest (each, an “**Entry**”) as submitted by an individual “**Entrant**”) is subject to the terms and conditions contained herein. By participating in the Contest, each participant unconditionally accepts and agrees to comply with and abide by the terms and conditions stated in these Official Rules. The sponsor for this Contest is Ensemble Travel, Inc. with an address at 261 Madison Avenue, 9<sup>th</sup> Floor, #945, New York, NY, 10016 and Ensemble Travel Ltd. with an address at 2 Queen Street East, 20<sup>th</sup> Floor, Toronto, Ontario, M5C 3G7 (together, “**Ensemble**” or “**Sponsor**”).

### KEY DATES

The Contest will begin at 12:00am EST on November 13, 2025 will close at 11:59pm EST on January 22, 2026 (the “**Contest Period**”).

### ELIGIBILITY

Participation in the Contest is only open to legal residents of the United States (excluding New York and Florida), and Canada (excluding Quebec). Participants in the Contest must be the greater of (a) at least 18 years of age or older or (b) the age of majority in their state or province of residence. Entries cannot be created in the name of a minor. Entries are open to individuals only, and businesses or other entities that are not natural persons are not eligible to participate.

The following individuals are prohibited from entering into the Contest:

- Employees of Ensemble or any of its Affiliates. “Affiliate” means any entity that directly or indirectly controls or is controlled by, or is under common control with Ensemble. For purposes of this definition, “control” means direct or indirect ownership of more than fifty percent (50%) of the voting interests of a party.
- Owners, managers, individual travel advisors who are employees, or other travel-selling representatives of a member agency of the Ensemble travel consortium (collectively, “Ensemble Advisors” and each an “Ensemble Advisor”).

Ensemble reserves the right to determine whether an Entrant meets the eligibility criteria for participation in the Contest in its sole discretion. This Contest is void where prohibited by law, outside the United States and Canada, in the states of New York and Florida, and in the province of Quebec.

### HOW TO ENTER

There are only two ways to enter the Contest:

1. **EXPO ATTENDANCE:** During the Contest Period:
  - a. Register for the 2026 Ensemble Virtual Cruise Expo using the designated link, completing all required fields, including identifying your applicable Ensemble Advisor; and
  - b. Attend the 2026 Ensemble Virtual Cruise Expo, held virtually on Thursday, January 15, 2026, from 7:00 p.m. to 9:00 p.m. EST, for a minimum of one (1) minute.

2. **WRITE-IN:** Entrants entering through a write-in submission must legibly handwrite or type (i) Entrant's complete name, (ii) Entrant's mailing address, (iii) Entrant's phone number, (iv) Entrant's email address, (v) Entrant's date of birth, and (vi) the following text between the quotations "We all go further, together", on a postcard or a card that is no smaller than 3 ½ x 5 inches and no larger than 4 ¼ x 6 inches, and mail the postcard or card with proper postage to:

All write-in entries must be postmarked by January 15, 2026 and received by January 22, 2026. There is a limit of one (1) write-in entry per envelope. Each envelope/postcard is considered one (1) entry into the Contest. Multiple entries submitted or entries completed by anyone other than the Entrant are void. Write-in entries must contain all entry fields outlined above; otherwise, they are void and will not be eligible to win.

Regardless of the entry method used to enter the Contest, there is a limit of one (1) entry per Entrant for the entire Contest Period. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant's entry and that Entrant may be disqualified from the Contest. In case of dispute as to the identity of any Entrant, entry will be declared made by the registered name and address on such entry. Your choice of entry does not impact your chance to win.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, labor strikes or work stoppages, faulty transmissions, technical malfunctions, or otherwise. Only fully completed Entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

## **ENTRIES**

There is a limit of one (1) Entry per Entrant. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant's Entry and that Entrant may be disqualified from the Contest. Any Entry received by Ensemble outside of the Contest Period, regardless of the reason, shall be null and void. Proof of submission will not be deemed to be proof of receipt by Ensemble.

## **PRIZES**

There are four (4) prizes available to be won by Entrants (each, a “Prize”, and together, the “Prizes”) as follows:

- Grand Prize (ARV \$8198 USD): One (1) eight (8)-day Viking European river cruise for the winning Entrant and one (1) guest (the "Guest") in a standard stateroom, up to Category E, based on double occupancy, cruise only, on an eligible 2026 or 2027 sailing, subject to availability, blackout dates, the applicable supplier's terms and conditions, and the additional restrictions set out in these Official Rules. The Grand Prize must be redeemed and booked through an Ensemble Advisor. Airfare, transfers, land extensions, cruisetours, and other optional services are not included.
- Gold Prize (ARV \$300 USD): One (1) \$300 AMEX e-gift card.
- Silver Prize (ARV \$150 USD): One (1) \$150 USD Amazon gift card.
- Bronze Prize (ARV \$150 USD): One (1) partner swag bag.

The approximate retail value of all Prizes is \$8748 USD.

For any Prize that may be extended to a Guest, both the Entrant and the Entrant's Guest must comply with all applicable requirements, obligations, and conditions set forth in these Official Rules.

### **DRAWING & ODDS**

On or about January 23, 2026, four (4) potential prize winners (each, a “Potential Winner” and collectively, the “Potential Winners”) will be selected in a random drawing from all eligible Entries received by Sponsor. The drawings will be conducted without replacement, with the Grand Prize drawn first, followed by the Gold Prize, then the Silver Prize, and finally the Bronze Prize. Each eligible Entry will have a chance to win only one (1) Prize. An Entrant's odds of winning a Prize depend on the total number of eligible Entries received. For example, if there are 100 Entries, then Entrant will have a 4% chance of winning a Prize. Once the Potential Winners have been selected, they will be notified and their eligibility verified in accordance with these Official Rules. If a Potential Winner declines a Prize, fails to respond within the required timeframe, or is or becomes ineligible or disqualified in accordance with these Official Rules, that Potential Winner's Entry will be removed from the Contest, and an alternate Potential Winner will be selected at random from the remaining non-winning eligible Entries. Sponsor is not obligated to select more than three (3) alternate Potential Winners for any Prize, and any Prize that cannot be awarded after up to three (3) such attempts may remain unawarded.

### **VERIFICATION AND NOTIFICATION**

EACH POTENTIAL WINNER IS SUBJECT TO VERIFICATION BY ENSEMBLE. ENSEMBLE'S DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE ADMINISTRATION, OPERATION, SELECTION OF THE POTENTIAL WINNERS AND OTHER MATTERS RELATED TO THE SWEEPSTAKE. AN ENTRANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL ENTRANT'S ELIGIBILITY AND COMPLIANCE WITH THESE OFFICIAL RULES HAVE BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE.

The Potential Winners will be notified by Ensemble by email and/or phone on or about January 23, 2026 at Entrant's e-mail address provided on the Entry (the “Notification”). Within 72 hours of the Notification (or such other longer period as is set out in the Notification, or unless such period is extended by Ensemble in its sole discretion), the Potential Winner must:

- reply to the Notification indicating their acceptance of the Prize;
- provide or complete any additional paperwork, including without limitation any liability, publicity (where permitted by law) and other consents, releases and/or other documentation (the “Paperwork”) as reasonably required by Ensemble, or as required by applicable law;
- if the Potential Winner is a Canadian resident, answer a time-limited, mathematical skill-testing question; and

- otherwise be eligible to receive the Prize and comply with the Official Rules in Ensemble's sole discretion.

After receipt of the required information from the Potential Winner, verification of any Paperwork by Ensemble, and confirmation of eligibility in all other respects by Ensemble, a Potential Winner shall be confirmed as a Prize winner (a "**Prize Winner**") and will be notified that they have been so confirmed as a Prize Winner by Ensemble.

In the event the Notification is returned as undeliverable, Potential Winner fails to respond to the Notification within 48 hours of Ensemble's Notification with their acceptance, does not provide the requested Paperwork, or if it is determined by Ensemble, in its sole discretion, that a Potential Winner is not eligible or disqualified in accordance with these Official Rules, then Ensemble shall select another alternate Potential Winner.

### **PRIZE CONDITIONS**

The following general conditions apply to the Prizes: (i) Prizes must be accepted as awarded and are not transferable, assignable, or convertible to cash (except as may be specifically permitted by Ensemble in its sole and absolute discretion); (ii) no substitutions are permitted, except at Ensemble's option; (iii) the Prize Winner and his/her Guest (if applicable) must: (a) travel on the same itinerary; (b) have all necessary documentation to permit travel; and (c) not have any barrier to re-entry into Canada or the United States (if and as applicable); (iv) the costs of everything not specifically stated above as included in the applicable Prize are the sole and absolute responsibility of the Prize Winner and his/her Guest, including, without limitation: ground transportation to/from airports; airline baggage fees; any necessary travel documentation (including a valid passport); travel and medical insurance; incidental expenses; tips and gratuities; income and other taxes; and all other costs and expenses not otherwise mentioned herein; (v) if the Prize Winner and/or his/her Guest do not utilize any component(s) of the Prize, then any such component(s) not utilized may, in Ensemble's sole and absolute discretion, be forfeited in their entirety and, if forfeited, nothing will be substituted in their place; (vi) Ensemble reserves the right at any time to: (a) place reasonable restrictions on the availability or use of the Prize or any component thereof; (b) substitute the Prize or a component thereof for any reason with a prize or prize component(s) of equal or greater value, including, without limitation, but solely at Ensemble's sole discretion, a cash award; and (c) modify travel dates and arrangements based on availability and provider approval; (vii) by accepting a Prize, the Prize Winner agrees to waive all recourse against the Released Parties if the Prize or a component thereof does not prove satisfactory, either in whole or in part; and (viii) the Prize Winner's Guest must: (a) be of the age of majority in his/her state or province/territory of residence; and (b) sign and return Ensemble's release (by the date indicated on the release form) indicating that he/she waives all recourse against the Released Parties relating to his/her participation in the Prize (including, without limitation, any travel related thereto). Certain blackout dates and travel restrictions may apply. Each Prize is also subject to any additional terms, conditions, and restrictions on use imposed by the applicable prize supplier(s). The Prize Winner is responsible for paying any applicable federal, provincial, state, local, income, and withholding taxes, if any. In the event that any tax withholding is required by law for a Prize, the Prize Winner authorizes Ensemble to make the corresponding deduction. Any Prize details not specified above will be determined by Ensemble in its sole discretion. Prizes are awarded "as is" without any warranty or guarantee, either express or implied, by Ensemble.

### **ADDITIONAL CONDITIONS APPLICABLE TO GRAND PRIZE**

In addition to the general conditions above, the following specific restrictions apply to the Grand Prize: The Grand Prize consists of one (1) standard stateroom, up to Category E, double occupancy, cruise only. The Grand Prize includes an eight (8)-day Viking European river cruise, standard included meals, and included shore excursions and tours as provided by the cruise supplier. Airfare, transfers, land extensions, and cruisetours are not included and are the sole responsibility of the Prize Winner and his/her Guest. The Grand Prize is not applicable to Christmas Market itineraries. The Grand Prize is not

transferable, and no credit will be issued for cruise fares of lesser value; the value may not be exchanged for cash. The Grand Prize is valid only on available 2026 or 2027 embarkations; blackout dates may apply and are subject to change at the cruise supplier's discretion. The Grand Prize is not combinable with any other offer or future cruise voucher. The Grand Prize is subject to stateroom availability at the time of booking, and reservations must be made within one hundred twenty (120) days prior to the selected departure date. The Grand Prize must be redeemed and booked through an Ensemble Advisor in accordance with Ensemble's instructions. Any additional add-ons, such as airfare, transfers, hotel stays, land extensions, or other optional services, are only payable by credit card, and airfare is available for purchase at full brochure rates. Additional restrictions imposed by the cruise supplier may apply, and all cruise travel is subject to the supplier's then-current terms and conditions, which the Grand Prize Winner and Guest must comply with.

### **GENERAL CONDITIONS AND RELEASES**

By participating in the Contest, each Entrant (on its own behalf and on behalf of any Guest, if applicable) agrees to the fullest extent allowed by applicable law to: (a) comply with and be bound by these Official Rules and the decisions of Ensemble, which are binding and final in all matters relating to this Contest; (b) defend, indemnify, release and hold harmless Ensemble, its Affiliates, prize providers and each of their respective past and present officers, directors, employees, agents, attorneys and representatives, and their successors and assigns (collectively, the "**Released Parties**") from and against any and all claims, expenses, losses, damages, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to an Entry, creation of an Entry or submission of an Entry, participation in the Contest, use or misuse of any website or platform or their associated terms of use, travel, lodging, acceptance, possession, attendance at, defect in, delivery of, inability to use, use or misuse of the Prize, or any portion thereof (including any travel or activity related thereto) and/or the broadcast, exploitation or use of Entry. Released Parties are not responsible if the Prize, or any portion thereof, is delayed, postponed or canceled for any reason, in which event that portion of the Prize is forfeited in its entirety and no substitution will be provided except as in Ensemble's sole discretion.

### **ADDITIONAL RELEASES**

The Released Parties shall not have any obligation or responsibility, including any responsibility to award any Prize to Entrants, with regard to: (a) Entries that contain inaccurate information or do not comply with or violate these Official Rules; (b) Entries, Prize claims or notifications that are lost, late, incomplete, illegible, unintelligible, damaged or otherwise not received by the intended recipient, in whole or in part, due to computer, human or technical error of any kind; (c) Entrants who have committed fraud or deception in entering or participating in the Contest or claiming the Prize; (d) telephone, electronic, hardware, software, network, Internet or computer malfunctions, failures or difficulties; (e) any inability of the Prize Winner to accept all or part of the Prize for any reason; (f) if a Prize cannot be awarded due to delays or interruptions due to Acts of God, natural disasters, terrorism, weather or any other similar event beyond Ensemble or the Released Parties' reasonable control; or (g) any damages, injuries or losses of any kind caused by any Prize or resulting from awarding, acceptance, possession, use, misuse, loss or misdirection of any Prize or resulting from participating in this Contest or any promotion or Prize related activities. Ensemble reserves the right, in its sole discretion, to disqualify any individual it finds to be (w) tampering with the Entry process or the operation of the Contest, or with any website promoting or required to deliver or administrate the Contest; (x) acting in violation of these Official Rules; (y) acting in an unsportsmanlike, unethical, illegal, or disruptive manner, or annoying, abusing, threatening or harassing any other person (or acting with the intent to do any of the foregoing) or (z) entering or attempting to enter the Contest multiple times in violation of these Official Rules or the use of any robotic or automated device in connection with your participation in the Contest. If Ensemble determines, in its

sole discretion, that technical difficulties, malfunction, error, disruption or damage or other unforeseen events compromise the administration, security, fairness, integrity, proper conduct or viability of the Contest, Ensemble reserves the right to void the Entries at issue, and/or terminate the relevant portion of the Contest, including the entire Contest, and/or modify the Contest and/or these Official Rules and/or award the Prize from all eligible Entries received as of the termination date. Ensemble reserves the right to suspend, modify or cancel the Contest before the end of the Contest Period. In the event the Contest is canceled, all Entries into such will be deemed null and void, no winners will be selected, and no Prizes will be delivered. Ensemble reserves the right and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Official Rules, to the extent necessary, for purposes of verifying compliance of any Entrant, or Entry with these Official Rules, or as a result of technical problems, or in light of any other circumstances which, in the opinion of Ensemble, affects the proper administration of the Contest as contemplated in these Official Rules.

#### **LIMITATIONS OF LIABILITY**

**THE RELEASED PARTIES ARE NOT RESPONSIBLE FOR: (A) ANY INCORRECT OR INACCURATE INFORMATION, WHETHER CAUSED BY ENTRANTS, PRINTING ERRORS OR BY ANY OF THE EQUIPMENT OR PROGRAMMING ASSOCIATED WITH OR UTILIZED IN THE CONTEST; (B) TECHNICAL FAILURES OF ANY KIND, INCLUDING, BUT NOT LIMITED TO MALFUNCTIONS, INTERRUPTIONS, OR DISCONNECTIONS IN PHONE LINES, INTERNET SERVICES OR NETWORK HARDWARE OR SOFTWARE (INCLUDING ANY TECHNICAL FAILURES CAUSED BY, DUE TO, OR IN RESPECT OF, THIRD PARTIES); (C) UNAUTHORIZED HUMAN INTERVENTION IN ANY PART OF THE ENTRY PROCESS OR THE CONTEST (D) TECHNICAL OR HUMAN ERROR OR NEGLIGENCE IN THE ADMINISTRATION OF THE CONTEST OR THE PROCESSING OF ENTRIES; (E) ANY INJURY OR DAMAGE TO PERSONS OR PROPERTY THAT MAY BE CAUSED, DIRECTLY OR INDIRECTLY, IN WHOLE OR IN PART, FROM ENTRANT'S PARTICIPATION IN THE CONTEST (INCLUDING USE OF ANY THIRD PARTY SOFTWARE OR SERVICES) OR RECEIPT OR USE OR MISUSE OF ANY PRIZE BY PRIZE WINNER OR GUEST; OR (F) ANY ASSESSMENT MADE BY YOU OR ANY OF YOUR ADVISORS REGARDING THE TAX TREATMENT, TAX CONSEQUENCES, OR ANY OTHER TAX MATTERS RELATED TO YOUR PARTICIPATION IN THE CONTEST. THE RELEASED PARTIES ARE NOT RESPONSIBLE IF ANY PRIZE CANNOT BE AWARDED OR FULFILLED DUE TO TRAVEL OR EVENT CANCELLATIONS, DELAYS, INTERRUPTIONS DUE TO ACTS OF GOD, ACTS OF WAR, NATURAL DISASTERS, WEATHER, OR TERRORISM OR OTHER CIRCUMSTANCE BEYOND RELEASED PARTIES' CONTROL.**

#### **DISPUTES.**

**FOR ENTRANTS WHO ARE LEGAL RESIDENTS OF THE UNITED STATES AND EXCEPT WHERE PROHIBITED BY LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE CONTEST OR ANY PRIZES AWARDED SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS, COLLECTIVE OR REPRESENTATIVE ACTION; (B) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS CONTEST OR ANY PRIZES AWARDED SHALL BE RESOLVED EXCLUSIVELY BY FINAL AND BINDING ARBITRATION ADMINISTERED IN WILMINGTON, DELAWARE, BEFORE A SINGLE ARBITRATOR, IN ACCORDANCE WITH THE U.S. FEDERAL ARBITRATION ACT AND THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION (AAA) OR ANOTHER RECOGNIZED ARBITRAL INSTITUTION SELECTED BY ENSEMBLE, AND NOT IN A COURT OF LAW; (C) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED UP TO A MAXIMUM OF TEN DOLLARS (US \$10.00), INCLUDING COSTS ASSOCIATED WITH ENTERING THIS CONTEST, BUT IN NO EVENT ATTORNEYS' FEES; (D) UNDER NO CIRCUMSTANCES WILL ENTRANTS (OR ANY OTHER PARTY) BE PERMITTED TO OBTAIN AWARDS FOR, AND HEREBY WAIVE ALL RIGHTS TO CLAIM, INDIRECT, PUNITIVE, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL**
